

Cessnock City Council The Great CPAC Bake-Off - Cooking Competition Terms & Conditions

1. How to enter:

- a) Entrants are required to prepare and bake a classic Butter Cake. The cake must meet the following minimum requirements:
 - i The cake should be cooked in a round or square tin, not a ring tin.
 - ii Round cakes should be a minimum of 20cm in diameter and square cakes should be a minimum of 18cms in diameter.
 - iii Commercial packet mix cakes are not allowed.
 - iv Cakes are to be iced using a plain glace icing and not decorated with any embellishments. Matching icing may be used to complement the flavour of the cake, i.e. coffee icing on top of a coffee cake.
 - v lcing must be restricted to the top of the cake only no icing is permitted on the sides of the cake.
 - vi Cakes should not be decorated other than a layer of plain icing as stated above.
 - vii Cakes can be any flavour orange, plain, lemon, caramel, coffee, marble, coconut, ripple, spice, chocolate (but not mud).
- b) Cakes will be cut and judged on their flavour, appearance and texture.
- c) Entrants must provide their own baking ingredients and equipment. The promoter will not provide these.
- d) Entrants are to deliver the baked cake to Cessnock Performing Arts Centre, 198 Vincent Street Cessnock NSW 2325. Cakes will only be accepted between 10:00am and 6:00pm on Wednesday, 31 March 2021.
- e) Entrants will be required to complete an entry form when delivering their cake. Information collected from the entrant will include their name, their contact telephone number, and/or their contact email address.



- f) The competition will be judged by Ellice Schrader, Vice President of the Country Women's Association (CWA) Cessnock Evening Branch. Should the Vice President not be available for judging due to unforeseen circumstances, the Vice President will nominate a representative of the Country Women's Association (CWA) Cessnock Evening Branch to act on her behalf.
- g) Judging will be conducted between 7pm and 7:45pm on Wednesday, 31 March 2021 at Cessnock Performing Arts Centre.
- h) At the end of the judging period outlined above, one winner will be chosen by Ellice Schrader, Vice President of the Country Women's Association (CWA) Cessnock Evening Branch. Should the Vice President not be available for judging due to unforeseen circumstances, the winner will be chosen by the Vice President's nominated representative of the Country Women's Association (CWA) Cessnock Evening Branch.
- 2. Prizes: 1 x first prize consisting of:
 - a) 1 x copy of the 50th anniversary celebratory edition of Margaret Fulton's beloved classic 'Margaret Fulton Cookbook', valued at \$39.99 RRP
 - b) 1 x hamper of selected goods, valued at no more than \$50.00
